



ONE EVENT LICENCE

FREQUENTLY ASKED QUESTIONS

Can a One Event Licence be issued without any charge?

No – even riders who forget their MNZ licence have to pay for them.

Is the One Event Licence New?

No, there is currently a One Event Licence (which will be discontinued). What is new is that the licence can be applied for and purchased at the event?

When do the One Event Licences start?

As soon as the clubs want to introduce them after September, 2004.

What events can the One Event Licences be used for?

Only club events. The licence cannot be used for Championships, Island Championships, New Zealand Championships or Street Races (this includes Beach Racing). If in doubt the club should ask when requesting the permit.

Do clubs have to make them available?

No – all clubs will be sent One Event Licences but it is the clubs decision as to whether they sell them. This is not a compulsory scheme.

If a One Event Licences is applied for – does it have to be issued?

No, the steward of the day has the jurisdiction to turn down an application at his/her discretion.

How many One Event Licences can be purchased before a rider has to purchase a full licence?

Four One Event Licences in one licence year (July 1 to June 30) is the maximum.

How many One Event Licences can be cashed in for a full licence?

Two One Event Licences (with documentation) not more than 6 months apart – can be used for a \$30 discount on a **new** full MNZ licence.

Is the owner of one or more MNZ One Event Licences entitled to vote as per the constitution?

No. Only full licence holders have voting rights.

Does a One Event Licence holder pay rider levies?

Yes.

Does the One Event Licence include rider insurance?

Yes, the rider is covered in the same way that full licence holders are for that event.

Can a fully licenced MNZ rider “cash in” their licence?

No – MNZ is not giving refunds on full licences. The new product is aimed at riders who don't currently have a MNZ licence.

Is the Price of a One Event Licence fixed by MNZ?

No, the club is entitled to add a handling and membership fee.

Can a full MNZ licence be purchased at an event?

No, full MNZ licences must be applied for through the office – no change.

Can anybody other than a Steward process and approve a One Event Licence?

No. Only MNZ Stewards can approve One Event Licence applications.

How often does the club pay MNZ for One Event Licences?

Each licence costs the club \$15. The fee must accompany the blue copy, which must be sent directly to MNZ (to be received within 48hrs of the event finish).

How many copies are there?

White Copy – This is the One Event Licence – must be kept by rider.

Blue Copy – Must be sent to MNZ with the \$15

Yellow Copy – Stays in the book.

What happens if a One Event Licence holder suffers a serious injury or is disqualified on the day?

The details must accompany the blue copy and be sent directly to MNZ. To be received within 48 hours of the event finish.

Can a One Event Licence be used if a full licence holder leaves his/her licence at home or loses it?

Yes – but they have to be eligible for the licence, pay the applicable fee and it must be an event that qualifies for the issue of One Event Licences.

Does a rider have to belong to an MNZ club in order to purchase a One Event Licence?

Yes, it is up to the club how much it will cost but it is mandatory that the rider applying for the licence to be a member of an MNZ affiliated club.

Can a One Event Licence be used for a club series held over a number of weekends?

Yes, but the rider would have to purchase a separate One Event Licence for each round of the Series.

Can One Event Licences be purchased at permitted events organised by licenced MNZ promoters?

Yes if they want to, because it is the MNZ steward who approves and issues the licence.

Can overseas riders purchase a One Event Licence?

No.

At what age can a One Event Licence be purchased?

*Any rider **8 years or over for Off Road Events, 13 years for Miniature Road Race (as per rule 24), Street Stock (as per rule 22-12) Junior Road Racing Classic (Rule 25-6) and Young Junior Road Race Rule (15-7) & 16 or over for all other events** can purchase a One Event Licence. If the rider is between the ages of 8 and 18, the parent or guardian must sign on the riders behalf.*

Does the Steward have to keep count of the individual One Event Licences?

No – MNZ keeps a database.
